1. PURPOSE

The purpose of this MIL AIP Supplement is to inform operators that the exercise ETAP-T 2023 will take place in Portuguese airspace, from the 2nd to the 14th of July, 2023.

ETAP-T 2023

2. INTRODUCTION

ETAP-T 2023 is a Joint and Combined training exercise scheduled and conducted by European Tactical Airlift Centre (ETAC) and hosted by the Portuguese Air Force, planned to be a Large Force Employment (LFE) Exercise in a multi-domain framework.

ETAP-T 2023 focus will be on LFE in a multi-domain environment. It is designed to provide the participating units with a vast array of tactical missions with the intent to share expertise, increase integration, tackle innovation and strengthen the bounds between the participants.

ETAP-T 2023 will take place at Airbase 11, Beja, where the assets will be based. The missions will be flown from Airbase 11, simulating a Deployable Operating Base, towards assigned airspace.

Air operations will be mainly developed in the East/Inland part of Portugal.

3. OBJECTIVE

The objective of ETAP-T 2023 is to provide adequate tactical training to all participating units that will work in a highly collaborative manner, sharing tactical knowledge, in a multi-domain environment to achieve the full potential of the participating units.

July 4th, 5th, 6th, 7th, 10th, 11th, 12th and 13th, BTN 1445 – 1830 (Appendix 1 – PM WAVE)

Areas and Corridors: APOLO, AQUARIUS, AURIGA, JUPITER, PUPPIS, TAURUS, TIGER 5, TIGER 6, TIGER NORTH (TN), TIGER SOUTH (TS), TC60, TC61 AND TC62.

NOTE 1: Due to the nature of the activities, taking place within ETAP-T 2023 areas, airspace users not involved in ETAP-T 2023 shall not use these areas during their activity time.

NOTE 2: Emergency, Firefighting, Public Service Obligation Flights, Medic Evacuation and Search and Rescue aircraft, will be able to cross any ETAP-T 2023 area, without delays and changes in their flight path/altitude, prior coordination with Lisboa Information.

NOTE 3: R26A in the Appendix is not an ETAP-T 2023 area and is used according to MIL AIP ENR 5.1.2.1 and ENR 5.1.2.2.

6. AFFECTED AERODROMES/HELIPORTS/ULTRALIGHTS RUNWAYS

Operators can only use the aerodromes, heliports and ultralights runways listed below (except Évora AD and Ponte de Sor AD that have specific restrictions described), outside ETAP-T 2023 activity time. Emergency, Firefighting, Medic Evacuation and Search and Rescue aircraft are exempt of these restrictions prior coordination with Lisboa Information.

AERODROMES:

CASTELO BRANCO (LPCB), ARP 39 50 54N 007 26 30W, within lateral limits of JUPITER.

COIMBRA (LPCO), ARP 40 09 22W 008 28 09W, within lateral limits of AURIGA and AQUARIUS.

ÉVORA (LPEV), an interdict area, 9.3Km radius centered at 38 31 47N 007 53 31W (AD ARP), was created to allow aircraft entry/exit, to/from West of Évora AD. This area is within lateral limits of TIGER 6, from GND up to 5000 FT AMSL. Military aircraft shall not enter this area.

In addition, airspace users involved in RT23 shall not use AC1 - LPEV access corridor 38 31 50N 007 59 55W - 38 31 52N 008 04 14W with 1852M width, from 4000 FT AMSL to 5000 FT AMSL. During activity time, corridor only available for traffic to and from LPSO with LPEV as alternate, if LPSO closed.

FERREIRA DO ALENTEJO (LPFA), ARP 38 02 21N 009 06 15W, within lateral limits of TIGER NORTH.

LOUSÃ (LPLZ), ARP 40 08 23N 008 14 24W, within lateral limits of AURIGA, AQUARIUS, TC61 and TAURUS.


